POSITION VACANCY

TITLE: Environmental Health Specialist

DUTIES: Employee in this position will be responsible for inspections, consultations, educating the general public on environmental problems and enforcement of state and local environmental health laws and regulations.

MINIMUM EDUCATION AND EXPERIENCE REQUIREMENTS: Graduation from a four-year college or university with 30 semester hours of coursework in the physical or biological sciences and two years of exposure in environmental health; or a four-year or Master's degree in environmental health from a program which is accredited by the National Accreditation Council for Environmental Health Curricula of the National Environmental Health Association and one year of experience in Environmental Health.

NECESSARY SPECIAL QUALIFICATION: Approval for registration as a Sanitarian or registration as a Sanitarian by the North Carolina Board of Sanitarian Examiners prior to employment.

ADMINISTERING THE TRAINEE APPOINTMENT: Appointees must be eligible for registration and apply for registration as an Environmental Health Specialist Intern within 60 days of employment. Employees may remain registered as an Environmental Health Specialist Intern until registration as a Sanitarian or up to three years, whichever comes first.

SALARY: \$38,213

Applicant must take and successfully pass a pre-employment drug test, Motor Vehicle Records driver license check, as well as submit to random, reasonable suspicion and post-accident drug and alcohol testing. A criminal background check must be completed by the County of Robeson for potential applicants. Applicants not residing in Robeson County will be required to provide a certified criminal background check from the county in which they reside.
